1. The regatta will be governed by the rules as defined in The Racing Rules of Sailing.
2. **Eligibility:**
 - 2.1. The Copper Cup Regatta is open to all PHRF and cruising yachts that meet U.S. Sailing qualifications.
 - 2.2. Eligible yachts may enter by submitting the following:
 - a) A completed Entry Form
 - b) A PHRF certificate
 - 2.3. Completed entries will be accepted on or before the dates and times specified:
 - a) If entering by U.S. Mail (Must be received by June 20, 2011)
 - b) If delivered (June 24, prior to 8pm or June 25, prior to 7:30am)
3. **Fees:**
 - 3.1. \$25 if received by June 20, 2011
 - 3.2. \$30 if received June 21, 2011 or later
4. **Schedule of Events:**
 - 4.1. Registration at Hi Seas Marina
 - a) Friday, June 24, 2011, until 8pm Central Daylight Time
 - b) Saturday, June 25, 2011, prior to 7:30am Central Daylight Time
 - c) Yachts failing to register may not be scored, at the discretion of the Race Committee
 - 4.2. Races:
 - a) Saturday, June 25, 2011 0800 hrs, Skippers Meeting and Weather Briefing
1000 hrs, Race 1: First Warning
A total of 3 races are planned. No race will be started after 1630 hrs.
 - b) The Race Committee has the right to provision a race on Sunday, June 26, 2011, if any or all of the races are postponed on Saturday, June 25, 2011.
 - 4.3. Other Events:
 - a) Saturday, June 25, 2011 Coffee and carbohydrates will be served from 7am to 8am
 - b) Saturday, June 25, 2011 Dinner at 1800 hrs or approximately 1 hour after the conclusion of the last race
 - c) Saturday, June 25, 2011 Awards to follow dinner, if all races are completed on Saturday, June 25
 - d) Sunday, June 26, 2011 Awards to follow the last race, if not completed on Saturday, June 25
5. **Measurement:**
 - 5.1. Yachts without a PHRF certificate will have their rating determined by the Race Committee.
6. Sailing Instructions will be posted on the Hi Seas Marina website (www.hiseasmarina.com/osa), and distributed to all yachts that have completed registration on June 25, 2011.
7. The racing area will be on Lake Michigan's Green Bay off the Oconto Breakwater in Oconto, Wisconsin.
8. The race will be scored by corrected time, based on class entered. Time allowances will be based on time on distance expressed in nautical miles.
9. Penalties will be assessed in accordance with The Racing Rules of Sailing, including published revisions.
10. **Safety Equipment:**
 - 10.1. Yachts shall comply with current US Coast Guard regulations.
